Who Needs to Complete a Child Care IDR?

- All licensed child care providers that serve children who are **18 months through 5 years old**, including child care centers, home-based providers, Head Start/Early Head Start, preschools, and pre-kindergarten, will need to register for the IDR.
- If your facility provides **ONLY** before and/or after school care for elementary children, you do NOT need to submit an IDR for those grades. Kindergarten students should be counted by their school if they're attending full time.

Getting Started

- Gather immunization records for children who are 18 months through 5 years of age as of the **date you submit your report**. You will **not** need to submit information for children younger than 18 months. You will be submitting total counts rather than individual children' records.
- You will need to know the total number of exemptions on file, as well as how many children have exemptions to EVERY required vaccine (exemptions can vary for each vaccination type).

Registering Your IDR Account


Registration





- This question is here so that you can easily link your preschool to an existing school. You also can also address any private schools not in our system. You will only see this question when selecting a child care/preschool.
- You will be asked if your facility is affiliated with a private grade school. If your preschool is physically located on a PUBLIC school campus, or if you do not operate any grades above preschool, select “No”.
- You might select “Yes” if you are:
 - A child care center that includes a private kindergarten
 - A private school that includes grades higher than preschool (for example, preschool and kindergarten, preschool through 8th grade, etc.)

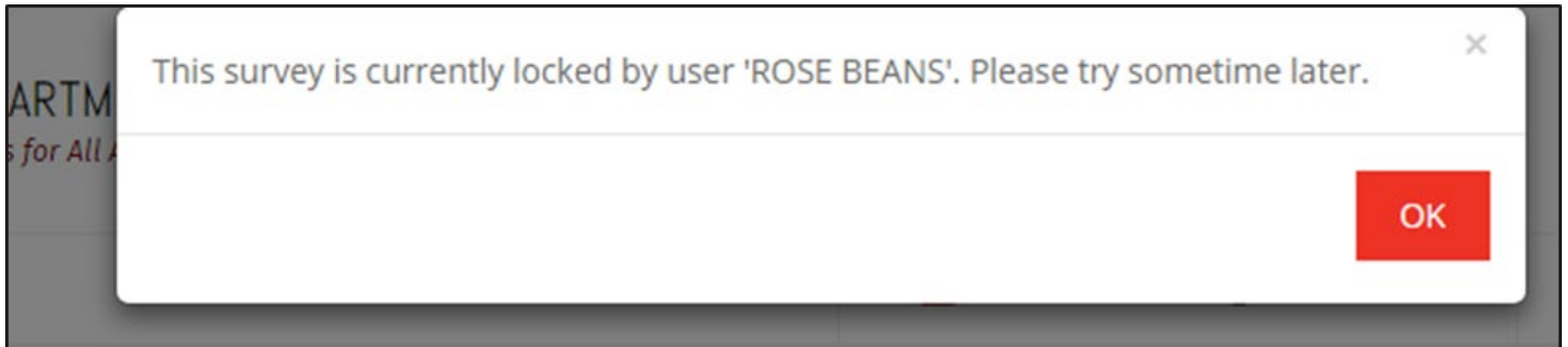
- Once you login or create your account, you can add your schools by clicking the “**Add/Remove School**” button on your home page. You will then follow the steps that begin on slide 9.

- This is also how you will **add additional schools** or remove schools from your profile, if needed.

Multiple Reporters? A-OK

- If more than one person will be reporting for your school, you may each add this school to your profiles. You will be able to see who last edited the surveys and when.
- Although more than one person may work on an individual survey, only **one person** may work **at a time**. If someone is already working in the survey you select, you will get a message indicating who is currently working in the survey.



- The section for each survey will remain **gray** until you start the survey. Surveys in progress will turn **yellow**, and SUBMITTED surveys will turn **green**.
- The printable PDFs will become available to you once you have submitted your survey to ADHS. The PDF is for your records only. The printed copy does not need to be sent to ADHS and will not replace the online submission of a survey.
- You can access your report via this portal after you have submitted and up until the IDR closes on November 15th.

For ADHS to receive your final data, you must click "Submit to ADHS". You must resubmit every time you make changes.

Submit to ADHS

These questions pertain to children 18 months through 5 years of age who are currently enrolled in your child care/preschool center.

 Student Count

Do you have 10 or fewer students (18 months through five years) enrolled in Child Care/Preschool? Yes No *

- If you have 10 or fewer children in your child care facility at the time of survey completion, you will be able to check the box indicating that you do not need to complete a survey **THIS YEAR.**
- You will **still need to create an IDR** for your facility, even if you need your facility to be added.
- You will register or login, select your school, go to the IDR survey, and check the box then hit **“submit to ADHS”**.

Understanding your Immunization Requirements

What is the difference between fully immunized and in compliance?

- **Fully immunized/coverage** – the percent of children who have received the [required doses](#) for each vaccine type and are up-to-date
 - Target range is **95% and above**
- **Compliance**- the percent of children who either have an [immunization record](#) or a [valid exemption](#) on file
 - Target range is **100%**
- For example: There are 100 children in a class. 80 are fully vaccinated for MMR, 10 are exempt and 10 are not exempt but also are not up-to-date.
 - Coverage: 80/100 are fully vaccinated → **80% fully immunized**
 - Compliance: 90 are either up-to-date OR exempt for MMR → **90% compliant**
- Arizona Revised Statutes 15-871 to 15-874 require all students to be vaccinated to be enrolled in school. The law states students are not allowed to attend and can be removed if they fail to attain the required immunizations or a valid exemption.

- Please answer each question as accurately as possible. Read each question.
- **Save your work often.** If you are logged out due to prolonged inactivity, accidentally exit the application, or there is a power failure, you may LOSE unsaved work.
- Saved work can be revisited at any time. You can safely log out and return later if you have saved your work. Please make sure your numbers add up to your enrollment.
- **Catch-Up** scenarios are unique situations where children cannot get vaccinated due to a minimum interval between vaccines. **Not because someone chooses to not vaccinate or did not make a timely doctor's appointment.**

What does conditional admission/ catch-up/minimum interval mean?

- For immunizations for which more than 1 dose is required, you will be asked how many children are on a “catch-up” schedule.
- This question is referring to children who have had at least one dose, usually late, and are in the minimum interval period before they can receive the next dose.
- For information about minimum interval periods, please see the [ADHS Guide to Arizona Immunizations Required for Entry: Child Care or Preschool](#).
- The catch-up question should NOT include children who have not had at least one dose, children who have an exemption form on file, or children for whom you have no record of immunization or exemption.
- If someone is choosing not to vaccinate their child they’re not in a catch-up scenario. This includes those foregoing vaccinations due to COVID-19.

- Once your survey has been submitted, you will be redirected to the home page where you will see a confirmation message and your survey button has turned **green**. The printable PDF will now be available for your records.
- All surveys must be submitted online to ADHS no later than **November 15, 2021!** You may continue to make changes until that date. A new survey must be submitted EVERY time you make changes. The IDR will be **unavailable** after **November 15th**. After this date, you will be able to print a copy of your survey IF you submitted it on time. You will not be able to make any changes to surveys after November 15th.

Helpful Tips:

- The questions in the child care survey will pertain to children who are 18 months through 5 years old, and not yet in kindergarten at the time you are filling out the survey. You do not need to report information for children younger than 18 months.



- **Save your work often!!** For security reasons, if you are inactive for 1 hour you will be logged out. Unsaved work will be lost, while saved work will be there when you log back in. There is a 5 minute warning that will appear before you get logged out.
- If you need more than one session to complete a survey, make sure to save before you log out. This will allow you to pick up where you left off.

Questions and Assistance

- If you have any questions or challenges while completing your IDR, please email AZIDR@azdhs.gov. Someone will return your email as soon as possible **during business hours**.
- Remember, your IDR is due **no later than November 15, 2022!** We encourage you to start early. This allows you time to get answers to any questions that you may have and still submit the IDR on time.

Hep A Questions

While Hep A is not required for child care attendance outside of Maricopa County, every Arizona child care/preschool must answer the following questions.

- As you will see noted in the IDR survey, **all preschools/child care facilities in all counties are required to answer the Hep A questions.**
- We are aware that this is only a child care entry requirement in Maricopa county, but we still need the data for analysis and reporting purposes. If you are outside of Maricopa county, your responses to Hep A questions **will not** affect your ability to get a certificate.
- **It is not necessary to add a comment in the comment sections about your facility being outside of Maricopa county or that Hep A is not required. This will be reflected when we assess the data.**

Impact of COVID-19 on Child Care

- The COVID-19 pandemic caused enormous strain on every aspect of life and preschools and child care suffered particularly hard.
- If your facility was closed but now is enrolled or planning to enroll sometime this year, please submit an IDR with as much information as possible.
- If you previously had 10 or fewer kids and thus did not enter data but now have more than 10, you must submit an IDR.
- If you know or have colleagues at other preschools, headstarts, and child cares who may have missed our emails please remind them of these requirements.



Quick Notes About the Pandemic

- The COVID-19 pandemic many changes to staff, enrollment, and more.
- This means students may not have had those critical check-ups that are important to keeping another outbreak at bay.
- Please reach out if you need any support in completing your record.
- We understand that staffing may have changed over the previous year. Please share with us any changes and how we can assist.
